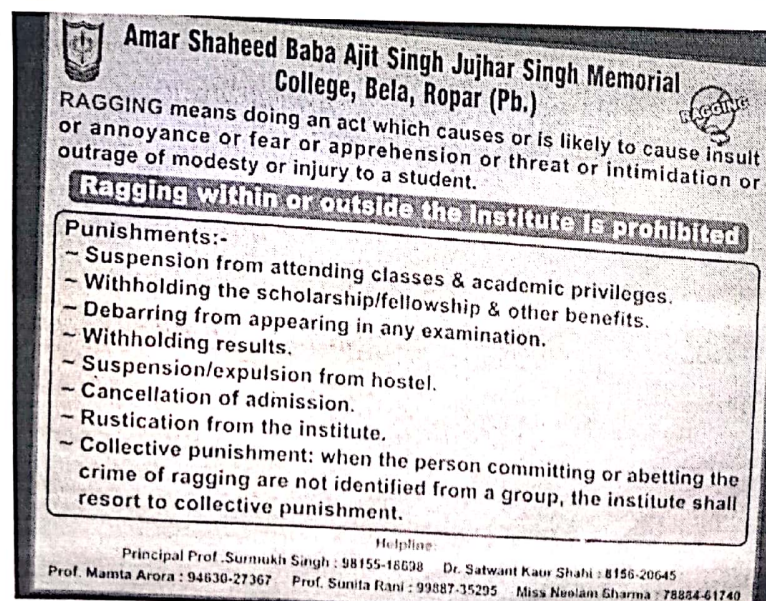

RAGGING means doing an act which causes or is likely to cause insult or annoyance or fear or apprehension or threat or intimidation or outrage of modesty or injury to a student.

Ragging within or outside the Institute is prohibited

Punishments:-

- Suspension from attending classes & academic privileges.
- Withholding the scholarship/fellowship & other benefits.
- Debarring from appearing in any examination.
- Withholding results.
- Suspension/expulsion from hostel.
- Cancellation of admission.
- Rustication from the institute.
- Collective punishment: when the person committing or abetting the crime of ragging are not identified from a group, the institute shall resort to collective punishment.

Anti-Ragging Committee

Ragging is an offence. The Supreme Court of India has taken a strong stand to prevent ragging in higher Educational Institutes. In 2007 Supreme Court directed that all the higher educational institutes should include information regarding ragging incidents in their brochures/prospectus of admission.

To follow the UGC Regulations against ragging, ASBASIS Memorial College Bela, (ROPAR) has constituted Anti-Ragging Committee. To make ragging free institute, Anti-Ragging Committee take timely initiative for the well being of the students and make them aware against the ragging by displayed anti-ragging banners in the campus. On the displayed banners it has been clearly mentioned that Ragging within or outside campus. On the displayed banners it has been clearly mentioned that Ragging within or outside the institute is prohibited and punishments are also displayed noticeably. In every new session the committee provide the guidelines to the students to make ragging free institution. According to UGC Regulations, our institute guide and direct the students to fill the anti-ragging forms at the start of session. From past few years no ragging case has been commenced in the college campus. Anti Ragging Committee make sure that in future our Institute will maintain ragging

free campus for the students. Helpline numbers of principal and Senior Teachers have been displayed on banners in case of any activity related to ragging occurred.

As per UGC Regulation, Ragging involves any of the following acts:

1. Whether by any words spoken / written which has the effects of teasing, treating or handling with rudeness a fresher or any other student.
2. Exploiting the students for completing academic task assigned assigned to an individual or a group and their financial extortion are the new act termed as ragging.
3. Any act by student that prevent, disturbs the regular academic activity of any other student.
4. The act of abuse by words, e-mails, posts, public insult, which would also include deriving perverse pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student will amount to ragging.
5. Any act of physical abuse like: Sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harms or any other danger to health would termed as ragging.

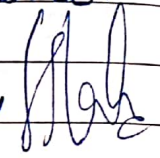
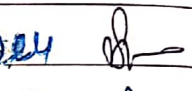
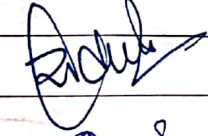
